

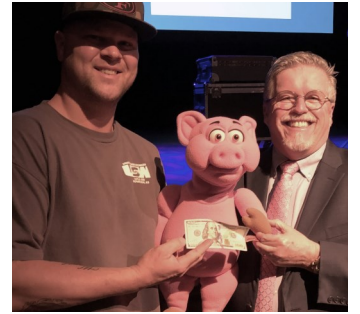

## Dormant Account Fee Notice

Effective January 17th, 2024, McPherson Co-Op Credit Union will begin to charge a \$10.00 per month fee for dormant accounts.

An account is considered dormant when there has been no deposit or withdrawal for a period of twenty-four (24) months. To avoid your account being considered 'dormant,' log into online banking, call the credit union or initiate a financial transaction.

Once your account has reached a zero balance and remains that way for a period of one month the account will be closed.
